Rules and Regulations

The following Rules and Regulations apply to each homeowner, their family members, and all guests and lessees.

Homeowner's Responsibilities

- 1. ANY EXTERIOR PAINTING or ALTERATION TO YOUR HOME OR LOT REQUIRES AN APPROVED **ARB FORM** (Architectural Review Board) Please contact Property Management office* for instructions.
- 2. Periodically clean your roof, driveway, sidewalk, and walls to prevent and remove mildew.
- 3. Maintain and irrigate your lawn properly: remove weeds, edge, trim shrubs and trees.
- 4. **Commercial vehicles**, campers, trailers, and boats/personal watercraft are not allowed within our community; **please store them inside your garage.**
- 5. Do not park on the grass.
- 6. **For Sale** are only permitted on top of the garage door or window. For Rent signs are not permitted.
- 7. Drive at safe/cautious speed. **Speed limit** within our community is **25 mph** and it is strictly enforced.
- 8. Whenever possible, park in your garage/driveway. This will allow for access of emergency vehicles thru our narrow street if and when the need occurs.
- 9. Trash pickup is on Monday and Thursday. Place trash at the curb after 5:00 pm on Sunday and Wednesday. Bulk pickup is only on Thursday. Garbage must be in enclosed containers.
- 10. Keep grills and trashcans out of site.
- 11. Pets must be leashed at all times when outside; scoop after your dog.
- 12. Cats are to remain indoors.

Violations of these Rules and Regulations may subject the violator to any remedy available to the Association under Florida Law.

Rules for use of Pool/Tennis court

Some of these Rules are mandated by the State of Florida and Palm Beach County and some are mandated by the TRENDS Homeowners Association.

- 1. ENTRY BY KEY ONLY. ANYONE FOUND CLIMBING THE FENCE OR BREAKING IN WILL BE SUBJECT TO ARREST AS A TRESPASSER.
- 2. TENNIS COURT AND POOL HOURS: "DAWN TO DUSK"
- 3. EMERGENCY EQUIPMENT IS MANDATED BY THE STATE OF FLORIDA AND PALM BEACH COUNTY. THIS EQUIPMENT IS FOR EMERGENCY USE ONLY. IT IS A MISDEMEANOR TO USE THIS EQUIPMENT FOR ANYTHING OTHER THAN EMERGENCY USE.
- 4. KIDS UNDER TWELVE (16) MUST BE ACCOMPANIED BY AN ADULT.
- 5. NO FOOD, GLASS BOTTLES OR ALCOHOLIC BEVERAGES ALLOWED AT POOL OR POOL DECK.
- 6. DIVING IS PROHIBITED ACCORDING TO THE LAW OF THE STATE OF FLORIDA.
- 7. NO RADIOS UNLESS USED WITH EARPHONES ARE ALLOWED IN POOL AREA.
- 8. BABIES AND CHILDREN IN DIAPERS NEED TO BE IN PROTECTIVE RUBBER SWIMWEAR.
- 9. NO PETS ALLOWED IN THE POOL/TENNIS COURT AREAS.
- 10. KEEP POOL GATE CLOSED AT ALL TIMES.
- 11. NO RUNNING AT POOL AREA.
- 12. SKATE BOARDS, ROLLER BLADES AND BICYCLES ARE NOT ALLOWED IN THE POOL AREA.
- 13. PLEASE MAKE USE OFTRASH CANS PROVIDED AT THE POOL.
- 14. SHOWER BEFORE ENTERING POOL.
- 15. BATHING LOAD (PEOPLE IN WATER) 21 PERSONS.
- 16. POOL MAY NOT BE USED FOR PRIVATE PARTIES OR FUNCTIONS. NO COMMERICAL USE OF THE POOL.
